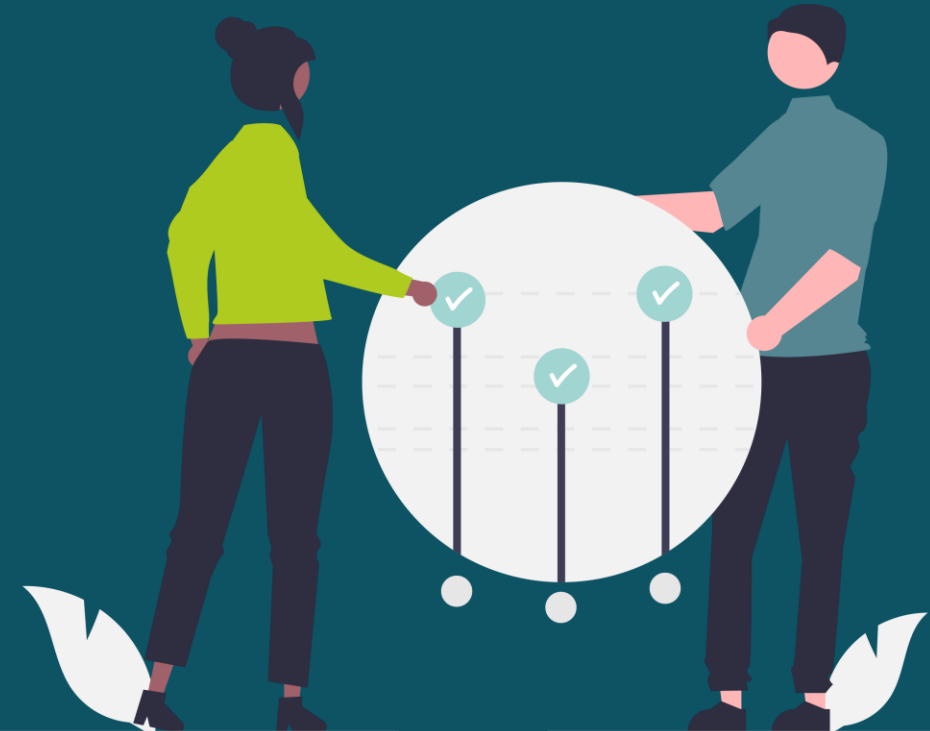

CCC Submission Timeline



6 March 2023

Opening of the CCC Submission Space on the Portal

- You will be able to upload your CCC on the Portal once ready.

15 March 2023

Deadline to upload your CCC to the Portal for Completeness Check

- Our Completeness Check is intended to confirm completeness and coherence ahead of the submission to the European Commission.
- The check will be done by NetZeroCities partners with the required expertise and will focus on helping you with your CCC. Please upload **your checklist too** if you can..
- Where needed, feedback will be provided with the option for minor amendment to be made
- Please note that if you have shared your draft with your City Advisor already, and you are waiting for or responding to feedback, then there may be flexibility on the **15 March** deadline.

15 April 2023

CCCs are sent to the European Commission

- The CCC review and Mission Label attribution process starts here and will last no longer than four months save exceptional cases.

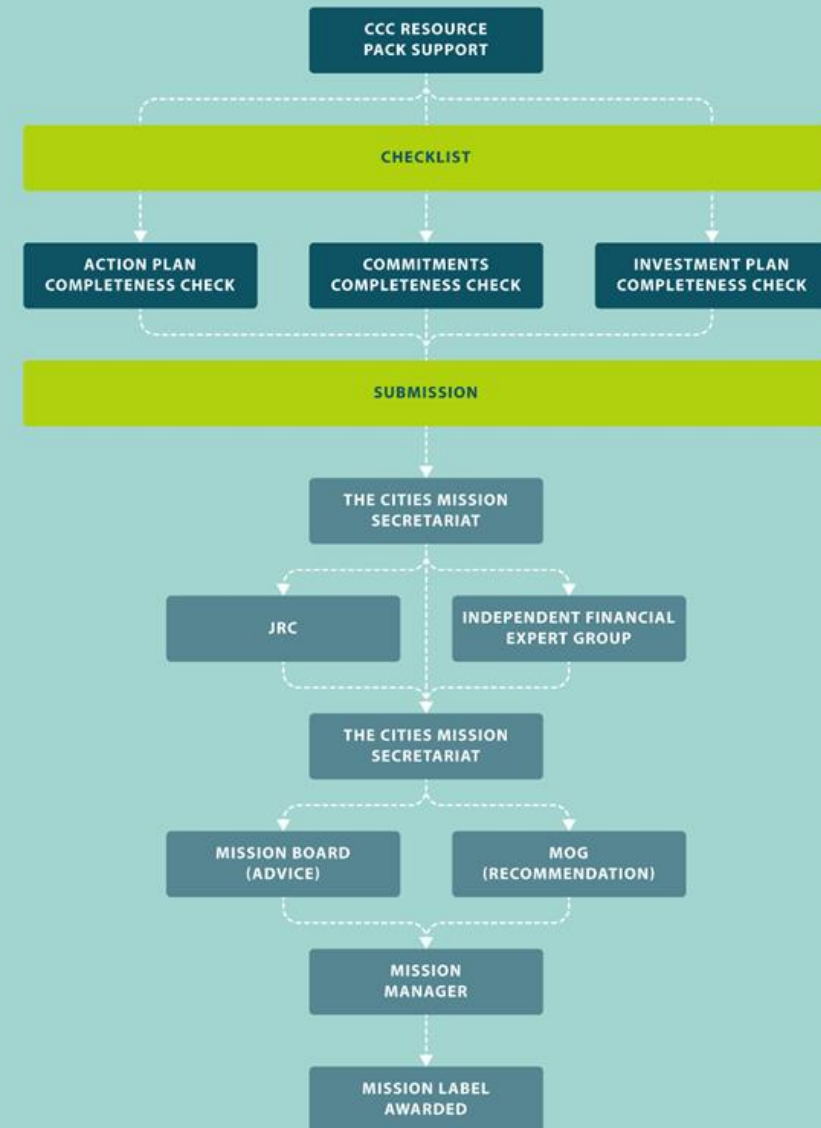


CCC Review Process

Proposed workflow in the European Commission:

4 months max, save for exceptional cases

- **Main** Commitments: Cities Mission Secretariat
- **Climate Neutrality Action Plan:** Joint Research Centre (JRC)
- **Climate Neutrality Investment Plan:** independent financial experts
- Consultation of **Mission Board** and **Mission Owners Group** (Commission-internal)
- **Mission Manager** decides whether to endorse the CCC and award the Mission Label.

EUROPEAN COMMISSION WORKFLOW



Award of the Mission Label

- All cities whose CCCs have gone through the review process will receive **feedback on the CCC's quality** and ways to improve further.
- Following the endorsement of its CCC, the city will receive the **Mission Label** (possibility of public ceremony involving a Commission representative).
- Following the award, the city may use the Mission Label in its **communication**.
- The Commission intends to publish the **list of cities** carrying the Mission Label.
- **Member States** will be regularly informed about the overall progress of the development of CCCs through the Strategic Programme Committee of Horizon Europe.
- **Monitoring:** The Mission Platform will carry on working with cities to update their CCCs and will monitor their implementation. It will keep the Commission and the Mission Board informed about the state of play.

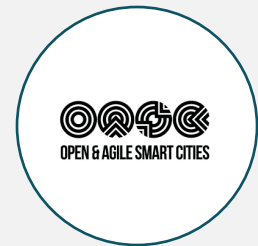
