

"Adapt Your Schoolyard" – Zaragoza Local Green Deal"

Zaragoza - Spain

Short description

The "Adapt Your Schoolyard" initiative is a key element of Zaragoza's strategy. This innovative program aims to transform schoolyards into greener, more sustainable environments through nature-based solutions. It addresses climate challenges, fosters biodiversity, and enhances urban sustainability while providing educational benefits. Environmental impacts include mitigating high temperatures and enhancing biodiversity. Socially, the initiative aims to improve well-being for students and teachers while fostering a culture of environmental awareness. With the development of a Climate Solutions Catalogue, Zaragoza is setting a precedent for replication in schools across the region and beyond. The challenge of adapting school playgrounds to the effects of climate change requires a multi-level approach, in which the key actors in the process (regional and municipal governments, municipal technical team, regional technical teams, educational teams, parents' associations) co-design and prioritise those interventions that are designed under transversal principles based on the promotion of biodiversity, temperature attenuation, the use of sustainable materials and low economic impact, and are adapted to the nature, location, configuration and needs of each school centre. The project highlights collaboration among key stakeholders, including the regional Government of Aragón and the educational community. It integrates environmental education into curricula, making sustainability a core component of student learning. Led by the Zaragoza City Council, the project targets two schools in its pilot phase in 2024: CEIP Hispanidad and CEIP José María Mir. These schools will see their outdoor spaces transformed by adding vegetation, shaded areas, and green infrastructure, with an allocated budget of €100,000.

Citizen Forest of Zaragoza

Zaragoza - Spain

Short description

The "Citizen Forest of Zaragoza" is a large collaborative environmental project aiming to transform Zaragoza into a more naturalised and resilient municipality. The core action is planting 700,000 trees by 2030, one for each inhabitant, across 1,200 hectares of public land. This initiative involves the City Council, an NGO, other public institutions, companies, citizens, and schoolchildren in a co-creation process. It seeks to combat climate change, improve air quality and health, increase biodiversity, and integrate waste utilisation through the use of compost.

Scope of LGD

• To transform Zaragoza into a more naturalised and resilient municipality committed to combating climate change and enhancing health benefits. It aims to create new green spaces and improve the health of inhabitants by facilitating the planting of 700,000 new trees. The scope also includes involving various stakeholders in a collaborative process and aligning with existing city strategies for climate change adaptation, air quality, green infrastructure, and circular economy].

Concrete measures/commitments

- Zaragoza City Council commits to increasing green infrastructure, as well as the connectivity of green and blue spaces.
- Zaragoza City Council commits to the planned recovery of up to 1,000 hectares
 of public lands with native forests.
- Zaragoza City Council commits to facilitating the planting of 700,000 trees.
- Zaragoza City Council commits to leading the structure of the initiative together with ECODES.
- Zaragoza City Council commits to coordinating overall execution and allocating public budgets/ensuring funding availability.
- Zaragoza City Council commits to monitoring project KPIs annually.
- ECODES Fundación Ecología y Desarrollo commits to increasing green infrastructure and connectivity of green and blue spaces.
- ECODES Fundación Ecología y Desarrollo commits to contributing to the planned recovery of up to 1,000 hectares of public lands.
