# **Campobasso - Italy**

## **Short description**

The Local Green Deal (LGD) in Campobasso supports the city's transition to renewable energy through the creation of Renewable Self-Consumers Groups (RSCGs) in multi-unit residential buildings. The LGD aims to install at least 30 photovoltaic (PV) systems on condominium rooftops by 2025, fostering energy self-sufficiency, cutting CO<sub>2</sub> emissions, and creating a model for affordable and democratic clean energy in Italy's mid-sized urban centres. By leveraging the updated regulatory framework, the LGD will facilitate access to financial incentives, reduce energy poverty, and build capacity among local developers, engineers, and administrators.

## Scope of LGD

• The scope of the LGD in Campobasso is to enable the creation of Renewable Self-Consumer Groups (RSCGs) in condominium buildings by facilitating the installation of at least 30 PV systems (25 kWp each) on shared rooftops. These configurations will enable energy sharing among residents in the same building, backed by private investment and supported by legal and technical partners. The goal is to produce a total of 840,000 kWh annually and avoid 344 tonnes of CO<sub>2</sub> emissions. The city will also support capacity-building, case simulation, and preliminary evaluations for interested residents and administrators.

## Short description

The Local Green Deal (LGD) in Campobasso supports the city's Sustainable Urban Mobility Plan (PUMS) by reducing traffic and emissions linked to employee commuting in the northern industrial zone. Through this LGD, the municipality collaborates with key companies to replace car-based commuting with public and shared transport solutions. With the installation of a new multimodal mobility hub and experimental shuttle services, the deal seeks to halve private vehicle use and cut emissions for over 100 employees by 2025.

## Scope of LGD

• This LGD aims to reduce commuter emissions in the northern industrial zone by providing new shuttle services, smart mobility planning, and company-based carpooling coordination. It directly supports Campobasso's strategic mobility and climate goals, aligns with national mobility law, and complements €3.72M in PNRR-funded investments in electric buses and interchange infrastructure.

## Short description

The Local Green Deal "Sustainable Mobility 2030 – School Mobility in Campobasso" aims to reduce private vehicle traffic during school hours through a pilot sustainable mobility project. Through collaboration between the municipality, SATI S.p.A. (the urban transport manager), and Istituto Comprensivo D'Ovidio, the LGD seeks to reduce CO<sub>2</sub> emissions, enhance awareness on sustainable lifestyles among youth, and promote low-emission transport habits city-wide.

# Scope of LGD

 This LGD aims to reduce the reliance on private transport for school commutes in Campobasso. By implementing a pilot project at D'Ovidio School, the city will promote the use of public transport, establish safe routes to school, and foster



environmental awareness through education. The deal supports the city's PUMS and its broader "Sustainable Mobility 2030" strategy.

## Concrete measures/commitments

- Provide an experimental shuttle service for D'Ovidio school students
- Procure and allocate two school buses for the pilot route
- Collaborate on campaigns promoting public transport use

## **Municipality of Campobasso commits to:**

- Develop safe pedestrian entrances and exits at the pilot school
- Promote "Kiss & Go" zones, cycle paths and bus stop access
- Organise student training on sustainable mobility and environmental impact
- Coordinate the LGD and monitor traffic and emissions reductions
